#### 312/2017 MATTERS ARISING

## 137/2017 Footpath Warden's Report / cycling

Increasing numbers of cyclists are using footpaths, including FP5,6,8,9,13 and 16, and in some cases such as FP16 these are dangerous to other users. Cllrs Cornish, Woof and the Clerk will discuss additional signage with Wokingham Borough Council (WBC) and will suggest that if WBC will provide suitable signage the Parish Council could install the signs. Ways to publicise routes available to cyclists will also be considered.

Cycling organisations and cycle shops may be able to assist with informing cyclists where they can and cannot go. It was noted that the new Green Way, and the future bridleways on the Fleet Hill and Manor Farm sites will provide new routes for cyclists.

# 139/2017 Improvements to the Rights of Way network

Walk related projects to mark the 10<sup>th</sup> anniversary of the death of David Hicks who was killed in action in Afghanistan were discussed. The Hicks family decided to proceed with an alternative scheme involving local schools and youth groups.

Cllr Pittock assisted the Blackwater Valley Countryside Partnership with its recent survey of the Blackwater Path. The condition of the path, signage and seating on the stretch from Grove Lake to Eversley Bridge was assessed in May 2017 and findings reported back to the Partnership.

The Clerk will arrange a meeting with WBC Rights of Way Officers to discuss various improvements to the condition of the routes and to the network as a whole.

#### 316/2017 IMPROVEMENTS TO THE RIGHTS OF WAY NETWORK

#### FP20 - Potential re-designation as a bridleway

• The landowners of the southern stretch running from Ambarrow Lane to Horseshoe Lake have now been identified and will be contacted to establish their views on the potential re-designation of the path.

#### FP33 - condition and network improvements

• Improvements to the section of FP33 running from where it meets FP29 to Longwater Lane are a priority, along with re-designation of the path as a bridleway to link in to the restoration scheme for this area. This will be discussed with WBC.

# New reserves and rights of way at Manor Farm and Fleet Hill Farm

 A meeting took place with WBC on 21 April 2017, the restoration and the new path network were discussed. Cllrs Weeks and Woof attended a site visit on 16 May 2017 with representatives from WBC, Cemex UK Ltd and the Royal Society for the Protection of Birds (RSPB).

Works at Fleet Hill Farm should be completed this year, followed by Manor Farm by the end of 2018. Negotiations are continuing over when the RSPB takes over management of the sites.

It was noted that there is no public access to the sites at present.

#### BP26 and BP34 - condition and network improvements

- The drainage report on FP26 was passed to WBC in July 2016. The project has been added to the list of potential projects for 2017/18 and WBC will consider this in due course.
- There has been no response from the owner of Brunsden Farm regarding the potential reinstatement of a link between BP26 and BP34. Cllr Woof and the Clerk will discuss this with WBC, and will also contact the local Ramblers. Cllr May agreed to make some additional enquiries.

## **Green Ways**

Green Way AR3 is due for completion in September 2017. Cllr Woof reported the
public consultation response at the recent Main Council meeting. A further consultation
is due to take place on the use of the route as a safe route to school – the Clerk has
asked WBC for an update on this.

The final route at the FBC Centre has not been formally confirmed but it is understood that bollards will be installed behind the existing vehicle gate, the gate will be locked when the Centre and car park are closed and users will have to use the existing path to Gorse Ride North. In the longer term the path may be routed through to Watkins Close.

The second phase of the Green Way project – the bridleway link from the California Country Park to Nine Mile Ride – is due to be completed by Spring 2018. This should alleviate the issue of horse riders trying to gain access to Gorse Ride North along the existing paths.

#### Circular walks

- The waymarking of the second circular walk is complete. The third circular walk will be waymarked on 26 August 2017, subject to permission from the landowner.
- Cllrs Cornish and Woof will be discussing future potential circular routes.

#### **Ambarrow Trail**

 There has been no further news, this may have been superceded by the Bracknell Forest pack of circular walks which includes a short walk around Ambarrow Court and Hill. Cllr Mrs Hartwell advised that the National Trust is working on a circular route including National Trust land at Simons Wood and Ambarrow Court.

#### **California Country Park**

- Cllrs May and Pittock advised that the boardwalk does not appear to be beyond repair
  and that short term repairs may be viable the Clerk will ask WBC for an update on the
  current position. The Clerk will also advise WBC that only one end of the boardwalk
  has a warning sign. It was agreed that the boardwalk issue should be followed up
  through the Amenities Committee.
- The car park signs do not have the correct information on opening times the Clerk will report this to WBC.

# 317/2017 FORWARD PLAN 2013-18

• An update to the Rights of Way section of the Plan was circulated, along with a draft action plan for 2017/18. Comments on the draft action plan should be forwarded to the Clerk by 4 August 2017.

#### 318/2017 CORRESPONDENCE

• There was no correspondence to report.

#### 319/2017 FORUM

 Cllr Pittock advised that the European legislation relating to requirements for Special Protection Areas (SPA's) may be changed, which could impact on future Suitable Alternative Natural Green Space (SANGS) provision and also the protection of existing SANGS. The importance of ensuring that new rights of way through SANGS are formalised as definitive rights of way and therefore protected was noted and will be pointed out to the WBC Rights of Way Team.
