Appeal Decisions:

APP/X0360/W/23/3329309: Pye Hill House, Jubilee Road (230195):

The development proposed is described as the erection of detached garden store and workshop. This was refused by WBC on 15/03/23. The Planning Committee had no objections.

Appeal Decision: Appeal dismissed 10/04/24.

The Decision Notice sited the main issue being whether the proposed development would be acceptable within the countryside, with particular regard to its effect on the character and appearance of the area. Please refer to the Decision Notice for full details and reasons.

08/2024 TREE PRESERVATION ORDERS (TPO) New TPO's:

- Trees at land to the rear of Range House, Nine Mile Ride TPO 1934/2023:
 - TPO was confirmed without modifications on the 22 March 2024.
 - A1 Trees of all species with stems which were 20cm or more in diameter at 1m above ground level located between the boundary of Valois and BK110951.
 - A2 Trees of all species with stems which were 20cm or more in diameter at 1m above ground level located to the east of the boundary between Valois and Range House, Range Road.
- Trees on land at 291A Nine Mile Ride TPO 1963/2024:
 - A1 Trees of all species On land at 291A Nine Mile Ride
 - W1 Trees of all species On land to the rear and west of 291A Nine Mile Ride

• 3 Manor Park Drive - TPO 635/1993, T18 (240784):

T18, Oak - Crown lift to create 4.5m canopy clearance above ground level; drop-crotch reduction of the outer canopy between 1 to 2m and crown clean.
